Be it ordained by the Mayor and City Council of the City of Peck, Nez Perce County, Idaho.

Section 1: That the sum of \$248,869.00 be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Peck, Nez Perce County, Idaho for the fiscal year beginning October 1, 2023.

Section 2: The objects and purposes for which such appropriates is made, and the amount of each object and purpose is as follows:

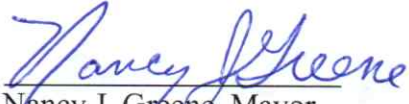

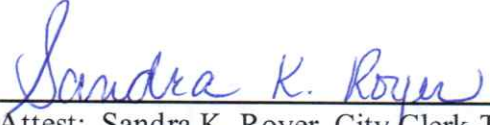
